## **60<sup>th</sup> International Congress of Submariners Regulations**

## §1. General provisions

- **1.1.** These Regulations define the rights and obligations of the Congress Participants and the Brotherhood of Submariners of the Maritime and River League Club with its registered office in Gdańsk at ul. Przemysłowa 6A 80-542 Gdańsk, entered into the register of associations, other social and professional organizations, foundations and independent public health care facilities of the National Court Register maintained by the District Court of Gdańsk-Północ in Gdańsk, VII Commercial Division of the National Court Register, under KRS number 0000117542, hereinafter referred to as the Regulations.
- **1.2.** The Congress will be held from 28 May 2025 to 1 June 2025 in Gdynia.
- **1.3.** The Congress is organized by the Polish Submariners Association, hereinafter referred to as the Organizer.
- **1.4.** The Congress Participants may be members of national submariners' organizations associated with the International Submariners Association, hereinafter referred to as Participants, excluding citizens of the Russian Federation and the Republic of Belarus.
- **1.5.** The detailed Congress program is available on the website <a href="www.60isc.pl">www.60isc.pl</a>.

#### §2. Registration for participation in the Congress

- **2.1.** In order to participate in the Congress, the Participant is obliged to register and pay the fee in the appropriate amount to the bank account indicated in the registration form generated during registration on the website <a href="https://www.60isc.pl">www.60isc.pl</a>.
- **2.2.** The Organizer is not responsible for the Participant providing incorrect or false data when registering for participation in the Congress.
- **2.3.** Sending the registration form via the website www.60isc.pl means acceptance of the provisions of these Regulations, as well as compliance with legal regulations and any other arrangements made between the Participant and the Organizer.
- **2.4.** The Organizer reserves the right to cancel the Congress by February 25, 2025 if the number of Participants who made a reservation and paid the appropriate fees is **less than 120**. In such a case, the Organizer will refund the fees paid by the registered Participants within 14 days of publishing the information about the cancellation of the Congress on the website <a href="www.60isc.pl">www.60isc.pl</a>.

# §3. Fees

**3.1.** The fee for participation in the Congress is PLN 2,200.00 (in words: two thousand two hundred Polish zlotys 00/100), while the accommodation fee is respectively: PLN 527.00 (in words: five hundred twenty-seven Polish zlotys 00/100) for a single room per day with breakfast and PLN 588.00 (in words: five hundred twenty-seven Polish zlotys 00/100) for a double room per day with breakfast.

- **3.2.** The fee for participation in the Congress and accommodation must be paid in the manner indicated in the registration form: to the indicated bank account or via the PayU online payment system also available on the website <a href="https://www.60isc.pl">www.60isc.pl</a>.
- **3.3.** Failure to settle the fee for participation in the Congress and accommodation within the time specified by the Organizer in the registration summary authorizes the Organizer to cancel the participation application, without incurring any liability for damages.
- **3.4.** All individual expenses related to accommodation, such as parking, telephone, mini bar, laundry, paid TV, etc., will be covered by the Participant on their own. The Hotel reserves the right to ask the Participant to establish security for individual expenses, in the form of a cash deposit or preauthorization on a credit card.
- **3.5.** The Participant is personally liable for damage caused in the Hotel and is obliged to cover the costs of repairing the damage caused before checking out of the Hotel.

## §4. Resignation from participation in the Congress

- **4.1.** The Participant may resign from participation in the Congress. Resignation should be made electronically via e-mail or in writing.
- **4.2.** In the event of the Participant's resignation from participation in the Congress:
  - made by 17 January 2025, the Organizer will immediately, but no later than within 14 days from the date of submission of the resignation, return the fees paid by the Participant to the bank account indicated by him/her, but deducting a handling fee of PLN 120;
  - made by 21 February 2025, the Organizer will immediately, but no later than within 14 days from the date of submission of the resignation, return the fees paid by the Participant to the bank account indicated by him/her, but deducting a handling fee of PLN 240.
- **4.3.** In the event of the Participant's resignation from participation in the Congress made after 21 February 2025, the Participant is not entitled to a refund of the fees paid.

## §5. Complaints

- **5.1.** Any complaints from Congress Participants towards the Organizer should be submitted via e-mail to the following e-mail address: 60isc.poland@gmail.com
- **5.2.** Complaints from Congress Participants may be submitted no later than 3 days after the end of the Congress.
- **5.3.** No complaints will be considered after the above-mentioned deadline.

#### §6. Personal data

**6.1.** In accordance with art. 13 sec. 1 and 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ EU L 119 of 04.05.2016, p. 1), hereinafter referred to as "GDPR", the Organizer informs that:

- 1) the controller of personal data obtained in connection with your participation in the Congress is the Organizer;
- 2) the personal data obtained will be processed on the basis of art. 6 sec. 1 letter a and letter b. b GDPR for the purpose related to your participation in the Congress;
- 3) the recipients of the obtained personal data will be persons or entities providing services related to the Congress, such as managers of individual facilities visited during the Congress, hotel operators, carriers, managers of the payment service, etc.;
- 4) the obtained personal data will be stored for the period necessary to ensure your participation in the Congress the storage period will cover the entire duration of the Congress, its settlement and the pursuit of any claims from entities providing services related to the Congress;
- 5) the obligation to provide personal data directly concerning you is a requirement for participation in the Congress, and the consequence of not providing the required data will be the inability to ensure your participation in the Congress;
- 6) in relation to the obtained personal data, decisions will not be made in an automated manner, in accordance with art. 22 of the GDPR;
- 7) Participants whose data the Organizer obtains have the following rights:
  - based on art. 15 of the GDPR, the right to access personal data concerning them;
  - based on art. 16 GDPR the right to rectify their personal data;
  - based on art. 18 GDPR the right to request the controller to restrict the processing of personal data, subject to the cases referred to in art. 18 sec. 2 GDPR, whereby the right to restrict processing does not apply to storage, in order to protect the rights of another natural or legal person, or due to important public interest considerations of the European Union or a Member State, and does not limit the processing of personal data until the end of participation in the Congress;
  - the right to lodge a complaint with the President of the Personal Data Protection Office, if they consider that the processing of personal data concerning them violates the provisions of the GDPR.

#### §7. Final provisions

- **7.1.** In the event that the Congress does not take place for reasons solely attributable to the Organizer, the Organizer will immediately return the amounts paid by the Participants to the bank accounts indicated by them.
- **7.2.** Any disputes that may arise from participation in the Congress will be resolved by the court competent for the seat of the Organizer, unless the provisions of generally applicable law provide otherwise.
- **7.3.** The Congress is a closed event and does not constitute a mass event within the meaning of the Act of 20 March 2009 on the safety of mass events (Journal of Laws of 2023, item 616).
- **7.4.** In matters not regulated by these Regulations, the provisions of Polish law shall apply.
- **7.5.** The Organizer shall not be liable for the Participants' belongings that may be lost, destroyed or stolen during the Congress.
- **7.6.** Participants shall bear full financial responsibility for any damage they cause both on the premises where any activities related to the Congress are carried out, as well as in the places of accommodation.

- **7.7.** These Regulations shall enter into force on 1 November 2024.
- **7.8.** The provisions of these Regulations constitute an integral part of the Application for Participation in the Congress and shall apply to all Participants.
